SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Acute toxicity, oral and inhalation (Category 3). Toxic if swallowed (H301) or inhaled (H331). Do not eat, drink or smoke when using this product (P270).

Hazard class: Skin corrosion or irritation (Category 2). Causes skin irritation (H315).

SECTION 4 — FIRST AID MEASURES
